TERMS OF APPLICATION & CONTRACT

1. The Expo is limited to those persons and companies which have contracted for exhibit space.
2. Exhibitors may not assign their contract for exhibit space to other persons or companies.
3. Full payment is due with signed contract.
4. Exhibitor agrees that no refund will be made upon execution of contract. There will be no exceptions. Exhibitor fee shall remain due even in the event that the Exhibitor does not use booth space for any reason. It is further agreed, that acceptance of this application by Zonta Club of Royal Gorge will constitute a contract between Zonta and the Exhibitor.
5. In the event, the Exhibitor does not claim or occupy their assigned space during the scheduled move-in time Zonta Club of Royal Gorge may terminate the agreement and reassign the space. The Exhibitor is not entitled to any refund for sums paid in advance to Zonta Club of Royal Gorge as payment for exhibit space.
6. Booths that are cooking or sampling food must adhere to the guidelines set by the Health Department and obtain all necessary licenses and permits.
7. Each Exhibitor must make provisions for safekeeping its goods from the time they are placed in the Exhibitor's booth until they are removed. Zonta Club of Royal Gorge shall not be responsible or guarantee to the exhibitor the safety of exhibit materials against fire, theft or any loss or injury. The Exhibitor agrees to assume all liability for damage to its own goods and to the Zonta Zing Expo facility by reason of the exhibit and shall hold harmless Zonta Club of Royal Gorge for all liability which might ensue by reason of the exhibit and its presence at the Expo.
8. All exhibits shall be removed by the end of the scheduled move-out time.
9. Exhibitor shall assume all responsibilities for damages to the Expo facility and property, and shall indemnify and hold harmless Zonta Club of Royal Gorge from all liability that might result from any cause whatsoever including accidents or injuries to their exhibitors, agents and employees.
10. Exhibitor shall indemnify Zonta Club of Royal Gorge against all liability resulting from negligence of Exhibitor, its agents and employees and for any loss or expense incurred by Zonta Club of Royal Gorge by reason of such negligence.
11. Zonta Club of Royal Gorge reserves the right to reject or prohibit any exhibit which in its opinion is not suitable to keeping with the character of the Expo.
13. In the Event, Zonta Club of Royal Gorge shall fail to hold the Expo, Zonta Club of Royal Gorge shall refund to Exhibitor all sums paid and such refund shall be accepted by Exhibitor in full settlement of all loss or damage suffered by Exhibitor.
14. Zonta Club of Royal Gorge reserves the right to remove from the Expo facility premises any and all property of the Exhibitor should the Exhibitor violate any of the conditions of these rules and regulations. This right may be exercised without prior written notice and without hearing.
